OVERALL GOAL: To bring to the attention of policy-makers the work being implemented at local/ regional level by authorities and stakeholders in order to develop strategic principles for sustainable marine litter management and beach cleaning. The EU Marine Strategy Framework Directive is a guide to proper management to protect more effectively the marine environment across Europe. It aims to achieve good environmental status of the EU's marine waters by 2020 and to protect the resource base upon which marine-related economic and social activities depend. The Marine Strategy Framework Directive constitutes the vital environmental component of the Union's future maritime policy, designed to achieve the full economic potential of oceans and seas in harmony with the marine environment.

OBJECTIVE OF THE EVENT: Principles for sustainable marine litter management are a pre-requisite for a sustainable, competitive Europe. Substantial work regarding the promotion of quality in sustainable marine litter management has been carried out widely through the development of policies, measures and actions at European local/regional level.

It is important to find solutions in the short term and the long term for marine litter and the threat to the tourist industry as well as a good environment for housing.

In the short term – how do we finance beach cleaning in EU? In the long term – start to deal with the problem of marine litter at its roots.

Triple-helix cooperation within this field has proved to offer great advantages. This conference is organised by Tillväxtsekretariatet Norra Bohuslän, the County Administrative Board of Västra Götaland, the Swedish Environmental Protection Agency, Region Västra Götaland and West Sweden.
